1ST QUARTER 2022 REPORT

Roadrunner Governors and Officers,

Our 1st Quarter Governors' Meeting was held via TEAMS Meeting since we had no sanctioned events scheduled until April. Barb, Bob and Ron reported on happenings at the 1st Quarter National Meeting in St. Louis. We reviewed the current list of Roadrunner Sanctioned events for 2022 and clarified the dates.

Ron reported on our current membership (823) and reminded Governors to make sure the data base is correctly updated for deceased, new or transferring members.

Bob reported on several Competition Rulebook changes, which he also sent to our Governors.

At the RE Meeting, the RE's discussed By-Law changes to be voted upon in 2022, as well as the need to make sure that the By-Laws and Standing Rules are clearly consistent and in agreement with each other. One of the most pressing changes discussed was the need for an exception to the By-Law pertaining to bids for upcoming National Conventions. As you know, the 2022 convention will be June 13-18 in Atlantic City, NJ. The current By-Law calls for bids to be submitted 17 months in advance of the event. However, since we had no bids at that time due to the pandemic situation, the National Corvette Museum offered to host it for next year. At the Governors Meeting in St. Louis that bid was accepted due to the unique circumstances. Therefore, we will be working on a By-Law change to accommodate this situation should it ever occur again.
